2. The present M.J.C. (contempt petition) is filed for non-compliance of the order dated 06.01.2020 passed in C.W.J.C. No.17184 of 2018 read with petitioner's representation dated 17.01.2020.

3. The concerned respondent was required to examine the petitioner's representation, insofar as the implementation of the communication dated 25.11.2016 of the Officer on Special Duty and it was addressed to the Vice - Chancellor, Maulana Mazharul Haque Arabic and Persian University, Patna.
