2. The present writ petition has been preferred for the
grant of following relief/s:-

*i) For an issuance of the writ of

3. Learned counsel for the petitioner submits that he will be preferring a fresh petition for getting the land measured alongwith requisite fee within four weeks.

4. If such a petition alongwith requisite fee is filed within the period specified above, the respondent No. 3, The Circle Officer, Sanhaura, Bhagalpur shall after putting all the concerned parties to notice shall get the land measured within a period of four months from the date the petition is received in his office.
