2. The learned counsel for the petitioners submits that petitioners seek anticipatory bail in connection with Forbesganj PS Case No. 1316 of 2022 registered under Sections 498A, 323, 342, 504, 506 and 34 of the IPC read with Sections 3 and 4 of the D.P. Act.

3. The learned APP submits that the offences for which the instant FIR has been instituted, carry punishment of seven years or less, the said submission is not disputed by
