2. This writ application has been filed on behalf of the petitioner primarily for direction to respondents concerned to appoint these petitioners on the post of lecturer in the light of order passed by this Hon’ble Court in CWJC No. 7905 of 2019 vide order dated 14.08.2020 (Nitu Kumari Vs. State of Bihar & ors.)
