2. The present writ petition has been preferred for the

*the nature of Mandamus directing the Respondents District Land Settlement Officer, Bhagalpur to correct the current Revisional Survey Khatiyani in which petitioners land has wrongly been entered in the name of other persons in view of Kramik/cadastral khatiyani in which the land in question is entered in name of petitioners ancestor.*

*And/or pass such other order or orders as your Lordships may deem fit and proper.”*
