3 20-09-2024 The petitioners in all these batch of writ petitions, have challenged the order passed by the respondent authorities, whereby either the process of recruitment for Panchayat teacher has been cancelled or the petitioner has been terminated from the post of Panchayat Teacher.

2. Since issues, involved in all these writ petitions, pertain to Panchayat teacher; having regard to the Bihar State Teaching Institutions Teachers and Employees (Dispute Redressal



and Appeal) Rules, 2020 and the decision rendered by this Court in **C.W.J.C. 10222 of 2022 (Rani Kumari Vs. the State of Bihar and Ors.)** along with the series of connected writ petitions, these writ petitions are hereby disposed of with liberty granted to the petitioners to approach the concerned District Appellate Authority for redressal of the grievances raised in these writ petitions as may be permitted under the law.
