2 13-05-2024 1. The present writ petition has been filed seeking the following relief(s):-

“1. That this is an application for issuance of a writ in the nature of mandamus directing and commanding the respondents to remove the illegal and forcible encroachment made by the private respondents upon the land bearing khata No. 145, plot No. 200 area 0.03 acre nature Rasta Anabad Sarva Sadharan, plot No. 201 area 0.20 acre nature Rasta, Plot No. 388 area 0.29 acre category Sarva Sadharan Bihar Sarkar Ahara and Khata No. 144, Plot No. 195 area 0.03 acre nature Anabad Bihar Sarkar situated under mauza Kushumhara Thana No. 91.”

2. At the outset, the learned counsel for the petitioner seeks liberty on behalf of the petitioner to approach the District Magistrate, Rohtas at Sasaram for redressal of his aforesaid grievances and enforcement of the order dated 02.11.2023, passed by the Circle Officer, Akorhigola, Rohtas in Encroachment Case No.01.2023-24. Liberty so sought is granted.

3. It is needless to state that in case appropriate



representation is filed, within a period of two weeks from today, the District Magistrate, Rohtas at Sasaram shall take appropriate action, in accordance with law, forthwith.

4. The writ petition stands disposed off on the aforesaid terms.
