3 19-04-2024 This is the second attempt of the petitioner for grant
of regular bail.

2. Heard learned counsel for the petitioner and
learned APP for the State.

3. The petitioner seeks bail in connection with
Hajipur Sadar P.S. Case No. 153 of 2022 registered for the
offence under Sections 20(1-b)a, 26 of the Arms Act.

4. Pursuant to the order dated 1.3.2024, report of
the District Judge, Vaishali has been received regarding the
stage of trial of the cases pending against the petitioner and the
same is as follows:-

5. The petitioner is in custody since 2.3.2022.

6. Since the petitioner is facing trial in six cases, this Court is not inclined to grant bail to the petitioner.
