4 18-07-2024 Heard learned counsel for the petitioner, Mr. Ranjeet Kumar, learned APP for the State and Mr. Anjani Kumar Jha, learned counsel for the opposite party no.2.

2. A joint compromise petition has been filed by the parties (Shilpi Kumari & Ashish Ranjan) and the parties have agreed to settle their disputes.

3. In view of the above, this application is allowed. The order dated 17.06.2022, passed by the learned Sub-Divisional Judicial Magistrate, Patna in Complaint Case No. 4184 © of 2022 is hereby quashed.
