2. Learned counsel for the parties are in agreement
that the present case is squarely covered by a judgment rendered
by the learned Division Bench dated 18.04.2018, passed in
L.P.A. No. 1472 of 2015 (The State of Bihar & Ors. vs. Rhituraj
Saraubh and Anr.) and the order of the Single Bench of this
Court dated 11.05.2018 passed in C.W.J.C. No. 8963 of 2018



(Chandra Shekhar Azad and Ors. vs. State of Bihar and Anr.).
