2      02-04-2024                      1. Heard learned counsel for the petitioner and  
learned A.P.P. for the State.

2. The petitioner apprehends his arrest in a case  
registered for the offences punishable under Sections 467, 468,  
471, 420, 272, 273, 120(b) of the Indian Penal Code and  
Sections 30(a), 36 and 41(1) of the Bihar Prohibition and Excise  
Act, 2016.

3. Learned counsel for the petitioner submits that  
petitioner has antecedent of one case.

4. Allegation is of recovery of 3061.08 litres of liquor  
from a truck.

5. Learned counsel for the petitioner submits that  
petitioner was not arrested from the spot, as such, nothing was  
recovered from his conscious possession and is neither the



owner nor the driver of the seized truck and petitioner came to be implicated based on the confessional statement of co-accused, namely, Bindu Fauzi @ Bindar in police custody which does not have any evidentiary value in the eye of law.

6. Learned A.P.P. for the State opposes the prayer for anticipatory bail of the petitioner.

7. Considering the submissions made by the learned counsel for the petitioner, the petitioner above-named, in the event of his arrest or surrender before the learned Court below within a period of six weeks from today, be released on anticipatory bail on furnishing bail bonds of Rs.5,000/- (Rupees Five Thousand) with two sureties of the like amount each to the satisfaction of the learned court below where the case is pending/successor court in connection with Majhauiliya P.S. Case No. 654 of 2021, subject to the conditions as laid down under Section 438 (2) of the Cr.P.C.
