This writ petition has been filed for quashing of the office orders as contained in Memo No. 1131 dated 20.06.2023 passed by the Director, Secondary Education, Education Department, Govt. of Bihar, Patna (Respondent No. 2) and Memo No. 1633 dated 03.09.2022 passed by the Regional Deputy Director of Education, Tirhut Division, Muzaffarpur (Respondent No. 3) whereby petitioner has been terminated from the post of Assistant Teacher, Sanlagna Abhyasshala,



DIET, Ram Bagh, Muzaffarpur and to command the respondents to reinstate the petitioner and grant all consequential benefits.
