State.

2. Petitioners apprehend their arrest in a case registered for the offence punishable under sections 147, 149, 341 , 323 , 307, 504, 506, 448 , 354 and 379 of the Indian Penal Code .

3. As per F.I.R., all the accused persons including these petitioners are alleged to have abused the informant and on protest by the nephew of the informant, he was assaulted by means of iron rod due to which he sustained injury .

4. It is submitted on behalf of the petitioners that the petitioners are innocent and have falsely been implicated in this case . Allegation against these petitioners is general and omnibus. No specific allegation of overt act is alleged against them. Specific allegation of assault is against co-accused *Sanjeet Sah* who has already been granted bail by the Co-



ordinate Bench of this Court vide order dated 01.05.2024 in Cr. Misc. No. 26323 of 2024. Moreover, the matter has already been compromised between the parties. Petitioners claim clean antecedent.

5. Learned counsel for the State oppose the bail petition.

6 Considering the aforesaid facts and circumstances of the case, in the event of arrest or surrender within six weeks from today, let the petitioners, as named above, be enlarged on bail on furnishing bail bond of Rs.10,000/-(ten thousand) each with two sureties of the like amount each to the satisfaction of the learned Judicial Magistrate 1st Class, Hajipur, Vaishali in connection with Jandaha (Mahisour) P.S. Case No. 357 of 2023 , subject to the conditions laid down under section 438(2) of the Code of Criminal Procedure .
