- 3 02-02-2024 1. Heard learned counsel for the parties concerned.
2. The present petition has been filed for restoration of a writ petition bearing C.W.J.C. no. 14235 of 2015, which has stood dismissed on account of non-prosecution vide order dated 21.12.2022.
3. Learned counsel for the petitioner submits that due to bonafide mistake, he could not appear on 21.12.2022, when the case was called out, hence, a sympathetic view may be taken and the aforesaid writ application be restored to its original file.
