2. The writ application has been filed for the
following reliefs:-

(i) *To direct the respondent
authorities to modify the memono. 3211
dated 28.06.2012 issued b y the District
Education Officer, Madhubani to the extent
to change the date of promotion to the
Senior Grade – VIII for Headmaster in the
pay-scale of Rs. 9300 – 34800 with Grade*



*Pay of Rs. 5400/- with effect from the date ,
when the petitioner completed 12 years of
his service in the pay – scale of Graduate
Trained Teacher (equivalent to Headmaster
of a Middle School) with all consequential
benefits including difference of salary with
interest.*

3 . At the outset, by referring paragraph 7 of counter affidavit, learned counsel for the State stated that the grievance of the petitioner has already been redressed vide order dated 29.06.2024 , i. e., Annexure R/ 1 to the counter affidavit and as such , the present writ application has become infructuous.

4. Considering the aforesaid facts, this writ application is disposed of with a direction to the concerned authority to issue order of consequential benefits, if any , to the petitioner as early as possible .
