The present M.J.C./Contempt is filed for non-compliance of the order dated 20.07.2021 passed in C.W.J.C. No. 9137 of 2021.

2. The present M.J.C.-Contempt is filed in the year 2024. Cause of action accrued in the month of July, 2022, whereas the present M.J.C-Contempt is filed in the year 2024. In the light of Section 20 of the Contempt of Courts Act, 1971, the present Contempt petition is not maintainable. Co-ordinate Bench in the case of *Dr. Rajesh Kumar Sinha & Ors. Vs. The*



Union of India & Ors. bearing *M.J.C. No. 1840 of 2023 in C.W.J.C. No. 13888 of 2016*, elaborately considered Section 20 of Contempt of Courts Act, 1971, read with Article 215 of the Constitution. In the light of principle laid down by the Co-ordinate Bench, the present M.J.C./Contempt Petition is not maintainable.

3. Accordingly, petition stands disposed of as not maintainable, reserving liberty to the petitioner to invoke fresh C.W.J.C., in accordance with law.
