ORAL ORDER

3 26-06-2024 The present writ has been filed seeking the following relief:-

“1. That the petitioner invokes the writ jurisdiction of this Hon'ble Court for the issuance of an appropriate / writ / order / direction commanding upon the respondents to immediately remove the



illegal construction over encroached land/passage made by the respondent no.- 9 on Plot No. B/6 of Rehabilitation Scheme No, 1 at Gouri Shankar Mandir Colony, Police Station Alamganj, Thana No.-11, District Patna, within Circle Sandalpur and Sub-Registry Patna City under Patna Municipal Corporation.”
