4 01-10-2024 The present writ petition has been filed seeking the following reliefs:-

“1(i). For quashing of letter No. 243, dated 10.03.2023(Annexure- 4) and memorandum dated 01.04.2023(Annexure- 4A), issued by Block Panchayati Raj Officer-cum- Executive Officer, Phulwarisarif District- Patna, by which the petitioners have been directed to deposit Rs 2,38,350/- within 24 hours otherwise FIR will be



instituted against the petitioners.

(ii). Be further pleased to stay the operation of impugned letters (Annexure 4 and 4A) during the pendency of the writ case.”

2. At the outset, the learned counsel for the petitioners seeks liberty on behalf of the petitioners to approach the District Magistrate, Patna for challenging the aforesaid order dated 10.3.2023, passed by the Block Panchayat Raj Officer-cum-Executive Officer (Panchayat Raj), Phulwarisharif. Liberty, so sought, is granted.
3. Accordingly, the present writ petition stands disposed off.
