2. The present modification has been preferred on
behalf of the petitioners to modify the order dated 22.03.2024
passed in C.W.J.C. No.14360 of 2023.

3. It is submitted by learned counsel for the petitioners
that the aforesaid writ petition was disposed of on 22.03.2024
but in cause title portion of C.W.J.C. No.14360 of 2023, due to
inadvertence certain mistakes have occurred and so in the order
sheet dated 22.03.2024, which may be corrected. The correct

indicated above and this application is disposed of.
