following relief(s):-

issuance of writ in the nature of certiorari
or any other appropriate writ(s), Order(s)
or Direction(s) for quashing the order as
contained in memo no. 217 dated
05.04.2024 issued under signature of
District Magistrate, Buxar in Bihar Crime
Control Act, Case No. 162/2023-24 (The*



State of Bihar vs. Pappu Kumar @ Pappu Singh) whereby the petitioner had been directed to physically present before the Station House Officer, Buxar at 10:00 A.M. to 04:00 P.M. dated 20.04.2024 to 05.06.2024 failing which the petitioner shall be arrested and for violation of the order a sum of Rs. 2 lacs shall be recovered as fine and the petitioner further prays for issuance of a direction for not to give effect of the aforesaid order and further the petitioner pray for issuance of such or directions as this Hon'ble Court may deem fit and proper in the facts and circumstances stated hereinafter."

2. The petitioner has statutory remedy of appeal before the Regional Commissioner against the order 05.04.2024. Without exhausting statutory remedy, petitioner has rushed to this Court. Accordingly, the present petition disposed of as premature.

3. Be that as it may, in the event of filing appeal before Regional Commissioner. The appeal along with the Interlocutory Application seeking interim against order dated 05.04.2024, in that event Appellate Authority is hereby requested to decide the Interlocutory Application for staying the operation of order dated 05.04.2024 within a period of one week. Thereafter, Appellate Authority is hereby requested to decided the petitioner's appeal to be filed within a reasonable



period of one month from the date of filing such appeal.
