2 22-07-2024 The present writ petition has been filed
seeking the following relief:-

"1. That this is an application for issuance of writ / writs, order / orders, direction /directions Mandamus to the respondent No. 2 (The District Magistrate, East Champaran Motihari) and Respondent No. 4 the Circle Officer, Bankatwa, Motihari East Champaran to get the Gairmajarua/Malik Land vacated and demarcate the land of the market, which was being used by the general people since last several years i.e. the one appertaining to Khata No. 16 Khesra No. 1585 area 2 acre situated in village-Semari, P.S. Lakhwara, Anchal-Bankatwa, District- East Champaran, which has been encroached by the private respondents No. 6 to 39 and also direct the Respondent No. 4 (Circle Officer-Bankatwa) to conclude the Encroachment Case No. 20/21-22."

2. After some arguments, the learned counsel for the petitioner seeks liberty on behalf of the petitioner to approach the Circle Officer, Bankatwa, Motihari, East Champaran, for redressal



of his aforesaid grievances. Liberty, so sought, is granted.

3. Accordingly, the present writ petition stands disposed off.
