**ORAL ORDER**

3      05-09-2024                      The present writ petition has been filed  
seeking the following reliefs:-

*“1. I. To issue a writ in the nature of  
Mandamus or any other appropriate  
writ / writs, order / orders, direction /  
directions for the grant of following  
reliefs, i.e. to direct the respondents  
(The State Authorities) to remove the  
encroachment from the piece of land  
bearing Khata No. 138, Survey Plot No.  
595, nature of land- Gair Mazarua Aam*



*Sadak in which 50 X 2 feet exclusive land of petitioner has been grabbed which has been encroached by the private respondents no. 7 and 8 by constructing pucca structure which is situated at village-Mustafabad, P.S. Gorea Kothi, within the District of Siwan.*

*II. To hold and declare that the private respondents no. 7 and 8 have grabbed the govt. land including the private adjoining land of the petitioner and encroached over the road used by the villager which is illegal obstruction to the way of the house of petitioner.*

*III. To direct the respondents to find out the actual nature of the land and then remove the illegal pucca structure constructed over the same because it is illegal and unauthorized structure.”*

2. After some arguments, the learned counsel for the petitioner seeks liberty on behalf of the petitioner to approach the Circle Officer, Gorea Kothi, District-Siwan for redressal of his aforesaid grievances. Liberty, so sought, is granted.



3. Accordingly, the present writ petition stands disposed off.
