2. The present writ application has been filed for directing the respondents to select/appoint the petitioner on the post of Anganwadi Sevika after cancelling the selection/appointment of private respondent no. 11 in Ward No. 4, Gram Panchayat-Patsanda, District-Jamui.

Learned counsel for the State raised preliminary objection and submits that the petitioner has not availed her remedy before the appropriate forum framed under the relevant *Margdarshika* for the appointment of Anganwadi Sevika & Sahayika and she has directly filed the writ petition in this matter.

4. In this view of the matter, the present writ application stands disposed off granting liberty to the petitioner to avail the remedy before the appropriate forum under the relevant *Margdarshika* of Anganwadi Sevika & Sahayika within 30 days from today, if cause of action survives.
