order(s), direction (s), for issuance of appropriate writ(s), order(s), direction(s) to the respondent authorities to build / construct the Panchayat Sarkar Bhawan for Gram Panchayat Raj, Chhotka Sankhe under the Uchkagaon Block/ Circle in the District of Gopalganj in one side of Plot No. 93 under Khata No. 246 in Revenue Thana No. 822 and its revenue village-Chhotka Sankhe which has already been reported by concerned Halka karamchari, which area is as 110 x 150 feet because as per revenue record upon the abovementioned land which total area of 8 Bigha 14 katha 16 Dhur where from 2 Bigha 12 Katha 1 Dhur has been assigned for General Public Interest whereupon Mahaviri Akhara and fare of Muharram have been organized in view of the order dated 15.03.2011 passed by the Collector/ Additional Collector, Gopalganj in Jamabandi Cancellation Case No. 03 of 1995-96 (Md. Sahabuddin Ansari and others Versus The State of Bihar and others) in exercising the power of section-4(h) of the Bihar Land Reforms Act."

2. At the outset, the learned counsel for the



petitioner seeks liberty on behalf of the petitioner to approach the District Magistrate, Gopalganj, for redressal of his aforesaid grievances. Liberty, so sought, is granted.
