Additional Public Prosecutor for the State.

2. The petitioner seeks bail in connection with Nawada  
(Nagar) P.S. Case No. 680 of 2021 registered for the offence  
punishable under Sections 33/34/36 of the Bihar Prohibition and  
Excise Act.

3. This is the second attempt of the petitioner for grant  
of bail. Earlier his application was rejected vide order dated  
25.08.2023 passed in Cr. Misc. No. 54386 of 2023. The  
petitioner is in jail since 19.01.2023.

4. As per the prosecution case, the petitioner is supplier  
of spurious liquor after consuming which Bhushan Rajbanshi has  
died. Though the learned counsel for the petitioner has argued  
that there is no recovery from the possession of the petitioner but



the name of the petitioner has transpired during investigation.

5. Learned counsel for the petitioner undertakes that if the petitioner is granted bail, he is ready to reside in Kolkata at the address give below:-

6. Considering the period of custody and also the undertaking given by the petitioner that he is ready to reside at Kolkata, this application is allowed.

7. Let the petitioner above named be released on bail, on furnishing bail bonds of Rs.10,000/- (Ten Thousand) with two sureties of the like amount each to the satisfaction of learned Exclusive Special Judge,1, Nawada/ concerned court in connection with Nawada (Nagar) P.S. Case No. 680 of 2021.

8. The petitioner is directed to mark his attendance in **Khidirpur Babu Bazar, South Port Police Station** on 1<sup>st</sup> Sunday of every month. Failure to do so, will result in cancellation of bail bond of the petitioner.
