3 12-02-2024 Heard Mr. Manoj Kumar Jha, learned counsel appearing on behalf of the petitioner; Mr. Shailendra Kumar Singh along with Mr. Utkarsh Utpal, learned counsel for Bihar State Food & Civil Supply Corporation and Mr. Uday Shankar Sharan Singh, learned GP 19 for the State.

2. Learned counsel appearing on behalf of respondent no.2 informs this Court that all the farmers have been paid their dues by the petitioner's PACS (Primary Agriculture Credit Co-



operative Society) against the quantity of grains lifted/purchased by the PACS for the Kharif Season, 2022-23, as would appear from **Annexure 'R/2'** (series) brought on record by way of counter affidavit filed on behalf of the respondent no.4, however, communication to that extent has not been made to the Bihar State Food & Civil Supply Corporation.

3. Considering the aforesaid submissions, learned counsel submits that the District Co-operative Officer, Madhubani is required to communicate to the Managing Director of Bihar State Food & Civil Supply Corporation as well as to the Co-operative Department so that no objection certificate can be issued.

4. With the above observation/direction, the present writ petition stands disposed of.
