2. Learned counsel appearing on behalf of the  
petitioner seeks to withdraw the Civil Review No. 193 of 2023.

3. Accordingly, the Civil Review No. 193 of 2023 is

Considering the aforesaid information that the substantial amount of retiral dues under different heads has been paid to the petitioner, I am of the opinion that the Finance Officer and the Registrar of the University must ensure to make payment of the remaining amount after calculating the interest and dispose of the representation, which has been filed by the petitioner, which is still pending, so that the petitioner may get satisfied.
