4 23-07-2024 Heard Mr. Samrendra Kumar Jha, learned counsel for the petitioners, Mr. Rajesh Ranjan, learned counsel for the informant and Mr. Parshuram Singh, learned counsel for the opposite party No. 4 as well as Mr. Jharkhandi Upadhyay, learned Additional Public Prosecutor appearing on behalf of the State.

2. The present application has been filed for quashing the F.I.R. i.e. Digha P.S. Case No. 222/2023 registered for the offences punishable under Sections 406, 420, 504, 506 and 34 of the Indian Penal Code.

3. After going through the F.I.R., it appears that serious allegations have been levelled against the petitioners of cheating. They have not transferred the land even after accepting a part of the amount.

4. In these circumstances, this application is dismissed.

5. Since this petition has been dismissed, the interlocutory application (I.A. No. 1 of 2023) filed for vacating stay has become infructuous.
