2 06-08-2024 The present writ petition has been filed
seeking the following relief:-

*“1. That, this application is being filed
for issuance of an appropriate writ,
writs or order / orders in the nature of
Mandamus for directing and*



commanding the respondents to remove the encroachment made by the local people over the government land bearing Thana No. 277 Khata No. 517 (Old), Khesara No. 274(Old) area 50 decimal, Khata No. 1122(new), Khesara No. 256(new) area 11.9 decimal, khata no. 817 (old), Khesara no. 273(old), area 17 decimal Khata 705(Old) Khesara No. 519 (Old) area 195 decimal Khata No.847(Old) Khesara 520(Old) 755 new, Khata No.188 Khesra-721 area 98 decimal, situated at near Fatki Kutti Chowk, inasmuch as both sides of the road has been encroached by constructing houses and shops and further for any other relief or reliefs for which the petitioner is entitled to in the facts and circumstances of this case."

2. After some arguments, the learned counsel for the petitioner seeks not to press the present writ petition, however, he seeks liberty on behalf of the petitioner to approach the Circle Officer, Madhepur, District-Madhubani for redressal of his aforesaid grievances. Liberty, so sought, is



granted.

3. Accordingly, the present writ petition stands disposed off.
