The present writ petition has been filed
seeking the following relief:-

*“1. That this is an application for
issuance of writ/writs, order/orders,
direction/directions in the nature of*



Certiorari for quashing the order dated 08.10.2018 issued by the Selection Committee Ward no. 18 Anganbari Centre No. 201 Gram Panchayat Sukhasan Block Kishunpur, District Supaul upholding the Letter No. 692 dated 13.09.2018 issued by Examination Controller, Bihar Sanskrit Shiksha (Education) Board, Patna, letter No. 2364/Pro dated 22.09.2018 issued by the District Programme Officer, I.C.D.S. Supaul and Memo No. 572 dated 25.09.2018 issued by C.D.P.O. Block Kishunpur, Supaul as well as for quashing selection of the newly selected Anganbari Sevika namely Muni Kumari at the Same Ward No. 18 of Sukhasan gram panchayat Block Kishunpur District Supaul on wrong, facts, further prayer for issuance of writ order or direction in the nature of Mandamus commanding them to post the petitioner on which she was holding as Anganwari Sevika Anganbari Centre No. 201, Gram Sukhasan Block Kishunpur, Supaul and for other relief/reliefs in the facts and



circumstances of the case.”

2. At the outset, the learned counsel for the petitioner seeks not to press the present writ petition, however, seeks liberty on behalf of the petitioner to avail such other alternative remedies as are otherwise available under the law, including that of filing a suit before the Ld. Civil Court having competent jurisdiction, for redressal of the aforesaid grievances. Liberty, so sought, is granted.

3. The writ petition stands dismissed as not pressed.
