The matter has been taken up on mentioning being made on behalf of the petitioners.

02. Heard learned counsels for the respective parties.

03. Learned counsel for the petitioners submits that Misc. Case No. 155 of 2020 has been filed under Section 34 of the Arbitration and Conciliation Act, 1996 (for short 'the Act') against the Award dated 17.10.2020 passed in Arbitration Case No. 7 of 2019 arising out of order dated 06.09.2019 passed in Request Case No. 64 of 2019. Learned counsel further submits



that the learned District Judge, Patna, transferred the matter to the court of learned Sub Judge-X, Patna for disposal where the argument of the parties has been completed and written argument has also been filed on behalf of the parties. Learned counsel further submits that prayer in terms of Section 36(3) of the Act has also been made for staying the Award in Misc. Case No. 155 of 2020 filed under Section 34 of the Act.

04. Learned counsel for the respondent submits that the respondent has already filed execution case and have moved before this Court by filing Civil Misc. Case No. 600 of 2024 for direction to the learned executing court to execute the Award in terms of guidelines issued in the case of ***Rahul S. Shah vs. Jinendra Kumar Gandhi and Others***, reported in ***(2021) 6 SCC 418***. Learned counsel for the respondent further submits that he has no objection if the Court, in seisin Misc. Case No. 155 of 2020, is directed to dispose of the same within a stipulated period.

05. Considering the fact that Award has been challenged in the year 2020 and neither any interim orders nor the final orders have been passed though specific prayer under Section 36(3) of the Act for stay has been made before the learned subordinate court, the court concerned is directed to take



up the Misc. Case No. 155 of 2020 and dispose of the same within three months from the date of receipt/production of a copy of this order.

06. Accordingly, the present petition stands disposed of with the aforesaid observation.
