ORAL ORDER

2 30-09-2024 Heard learned counsel for the petitioners and the State .

2. Petitioners apprehend their arrest in a case registered for the offence punishable under sections 147, 148 , 149, 341 , 448 , 323 , 307, 337, 504, 506 and 34 of the Indian Penal Code .

3 . The case of prosecution , in brief, is that on the alleged date and time of occurrence , when informant went to



the registry office at Gogri for transfer of name of his deceased Grand father in the property from his father to his brother and himself. In the meantime , all the accused persons including these petitioners came there and abused and assaulted informant and others. It is further alleged that after the alleged incident, when informant and his brother came to their house , all the accused persons armed with lathi , iron rod and other weapons entered the house of informant and assaulted informant and others due to which informant and others sustained injuries.

4. It is submitted on behalf of the petitioners that petitioners are relatives of informant and there is admitted land dispute between them due to which these petitioners have falsely been implicated in this case . Specific accusation of assault is against co-accused Bhusan Mistri and so far as these petitioners are concerned, there is general and omnibus allegation of assault against them. Case and counter case . Petitioners claim clean antecedent.

5 . Learned counsel for the State oppose the bail petition .

6. Considering the aforesaid facts clean antecedent of these petitioners and other circumstances of the case, in the event of arrest or surrender within eight weeks from today, let



the petitioners, as named above, be enlarged on bail on furnishing bail bond of Rs.10,000/-(ten thousand) each with two sureties of the like amount each to the satisfaction of the learned JM 1st cum Am Khagaria in connection with Beldaur P.S. Case No. 209 of 2024 , subject to the conditions laid down under section 438(2) of the Code of Criminal Procedure .
