2. The present Writ Petition has been filed for the following reliefs:-

“(i) For issuance of appropriate writ/writs, order/orders, direction/directions to the respondent authorities to take/accept the application of the petitioner for grant of electric connection on the aforementioned



address of the petitioner.

(ii) To further direct the respondents to grant a fresh electric connection on the application of the petitioner on the abovementioned address of the petitioner.”

3. Learned counsel appearing on behalf of the respondents has stated that the present writ petition may be disposed of with a direction to the Respondent No. 5 to accept the application made by the petitioner along with the requisite amounts and consider the same in accordance with law.

4. Having regard to the above made submission, the present writ petition is disposed of with a direction to the Respondent No. 5 to accept the application of the petitioner for an electrical connection along with the requisite amount and consider the same strictly in accordance with law. The Respondent No. 5 is directed to consider the said application within a period of four weeks from the date of the receipt of the copy of this order.

5. With the above directions, the present writ petition stands disposed of to the extent indicated above.
