ORAL ORDER

3 30-09-2024 The present writ petition has been filed
seeking the following relief:-

"1. That this is an application for quashing of order dated 26.07.2024, issued by the Circle Officer, Dulhin Bazar, Patna (Respondent No.7) vide memo no. 1481 dated 26.07.2024 as contained in Annexure-P8, by which he has directed the petitioner to not plough the land situated at Mauza- Lala Bhadasara, Village-Barichak, Thana No. 295, Khata No.476, Plot Nos. 698, 841,



area-5 acres 23 decimals without proper verification of records, measurement of land and ignoring the order dated 03.11.1998 passed in C.W.J.C No. 379 of 1998 by Hon'ble Mr. Justice S. J. Mukhopadhyaya (J) and further prays to pass such order/orders, direction/directions for which the petitioner is legally entitled."

2. At the outset, the learned counsel for the respondent-State submits, by referring to paragraph no. 9 of the counter affidavit filed in the present case that on account of typing error the plots number were wrongly mentioned in the Encroachment Case No. 03 of 2022-23 as Plot Nos. 698, 841 and 690 instead of Plot Nos. 891 and 962, hence the petitioner should appear before the Circle Officer, Dulhin Bazar, District-Patna and file his objection, if so advised.

3. At this juncture, the learned counsel for the petitioner seeks four weeks' time for filing his objection before the Circle Officer, Dulhin Bazar, District-Patna in connection with Encroachment Case No. 03 of 2022-23 as also seeks liberty to raise the issue of grant of compensation. Liberty,



so sought, is granted.

4. The writ petition stands disposed off.
