ORAL ORDER

2 20-03-2024 The present writ petition has been filed
seeking the following relief:-

"(i) For setting aside the order dated 03.09.2022 passed by Addl. Collector cum Addl. District Magistrate, Aurangabad in Aanganbadi Sewika/Sahayika Selection Appeal Case No. 18/2020/155/2020 whereby he has allowed the appeal filed by Respondent No. 6 against order dated 04.02.2020 passed by District Programme Officer, Aurangabad, Aanganbadi



Sewika/Sahayika Selection Appeal Case No. 18/2018 and subsequently the selection of petitioner has been cancelled and the respondent no. 6 has been reinstated for the Post of Aanganbadi Sewika, Rampur Panchayat Ward No. 12.

(ii) For issuance of appropriate writ (s), order (s), direction (s) to the respondent concerned to reinstate the petitioner on the Post of Aanganbadi Sewika in Rampur Panchayat Ward No. 12."

2. At the outset, the learned counsel for the petitioner seeks not to press the present writ petition, however, seeks liberty on behalf of the petitioner to avail such other alternative remedies as are otherwise available under the law, including that of filing a civil suit before the learned civil court of competent jurisdiction. Liberty, so sought, is granted.

3. The writ petition stands dismissed as not pressed.
