5 24-09-2024 Though the present writ petition has been filed, challenging the order dated 29.01.2013, passed by the Circle Officer, Minapur, District-Muzaffarpur, in Encroachment Case No. 01 of 2011-12, as also the order dated 17.07.2023, passed by the learned Collector-cum-District Magistrate, Muzaffarpur, in Encroachment Appeal Case No. 14 of 2013-14, however, at the outset, the learned counsel for the petitioners seeks liberty



on behalf of the petitioners to avail such other alternative remedies as are otherwise available under the law, including that of filing a civil suit before the learned civil court of competent jurisdiction for redressal of their subsisting grievances. Liberty, so sought, is granted.

2. The writ petition stands disposed off.
