Heard I.A. No. 01 of 2021 there is a delay of about 223 days in filing LPA No. 714 of 2021. In para 3 to 10 so many reasons have been assigned, however, delay has not been explained except the matter was tossing from one department to another department or one section to another section for the



purpose of examining whether it is a fit case for filing appeal and other material information. In the absence of showing sufficient cause for the delay of about 223 days and for bereft of reasons the appellants have not made out a case so as to condone the delay of about 223 days in filing LPA No. 714 of 2021.

2. Accordingly, I.A. No. 01 of 2021 for condonation of delay of about 223 days stands rejected. Resultantly, the present LPA No. 714 of 2021 stands dismissed.
