Heard I.A. No. 02 of 2021. There is a delay of about 01 year 08 months and 25 days in filing L.P.A. No. 731 of 2021. Perusal of para 2 to 10, it is as usual file was moving from one office to another office. Such reasons to condone the enormous delay of about about 01 year 08 months and 25 days is not permissible in the light of our order dated 25.07.2024 passed in L.P.A. No. 51 of 2021 in which we have taken note of number of decisions of the Hon'ble Supreme Court insofar as filing of belated litigation on behalf of the State.



Accordingly, I.A. No. 02 of 2021 for condonation of delay of about about 01 year 08 months and 25 days stands rejected. Resultantly, L.P.A. No. 731 of 2021 stands dismissed. Pending I.As, if any, stands disposed of.
