“1.A. Quashing the order passed by The Commissioner, Tirhut Division, Muzaffarpur in ICDS REVISION CASE No. 83/2022 dated 06.07.2023,
B. And, also to allow the petitioner to work as ANGANWADI SEVIKA at Anganwadi Centre No. 07 at Village Srinagar, Ward No. 16, of Block - Thakraha, Distt. -West Champaran,”
