*"1. The Writ Petition is being filed for quashing the order dated 31/07/2023 for removal of Mr. Prahlad Thakur, President, Patna Branch, Bihar Grih Raksha Vahini Swgan Sevak Sangh and charge of President is given to Mr. Kapil Deo Prasad Singh (Vice*



*President), Grih Raksha Vahini Swyan Sevak Sangh. The Petitioner is also removed from the membership of Sangh for six years. The order is passed by the President, Central Committee, Bihar Grih Raksha Vahini Swyan Sevak Sangh."*

2. At the outset, the learned counsel for the petitioner seeks liberty on behalf of the petitioner to avail such other alternative remedies as are otherwise available under the law. Liberty, so sought, is granted.
