2. This writ petition has been filed by the petitioner for a direction to the respondent authorities to pass order on his appeal which the petitioner has filed against the order of his dismissal communicated to him vide Memo No.5308 dated 20.10.2023 passed by the Director, SC & ST Welfare Department, Government of Bihar.
