2 24-09-2024 Though the present writ petition has been filed for quashing the notice dated 21.08.2024, issued by the Circle Officer, Shahkund, District-Bhagalpur, under Section 3 of the Bihar Public Land Encroachment Act, 1956 (hereinafter referred to as the ‘Act’, 1956), however, at the outset, the learned counsel for the petitioners seeks liberty on behalf of the petitioners to file objections before the Circle Officer, Shahkund, within a period of two weeks from today. Liberty, so sought, is granted.
