4 18-11-2024 Though the present writ petition has been filed for quashing the proceedings of Encroachment Case No.5 of 2023-24, however, at the outset, it is submitted by the learned counsel for the petitioners that till the time *Jamabandi* is existing in favour of the petitioners qua the land in question, the possession of the petitioners over the land in question, cannot be disturbed.



2. *Per contra*, the learned counsel for the respondent-State submits that such petitioners, in whose favour *Jamabandi* is existing, shall not be disturbed of their possession over the land in question, till the time *Jamabandi* is cancelled. It is directed, accordingly.

3. The writ petition stands disposed off on the aforesaid terms.
