2. The present writ petition has been filed seeking the following relief(s):-

“1.(i) That an appropriate writ may be issued commanding upon the respondent no.3, the Municipal Commissioner, Municipal



Corporation, Samastipur, to dispose off the Encroachment Case by removing the encroachment made by the Private Respondents No.6 and 7 from Aam Rasta (Road) appertaining to Mauza Chaklokman, Thana No.71, Khesra No.827 encroached area-136 sq. Kari and 104 Kari due to the reason of encroachment Aam Rasta (Road) blocked pursuant to the order dated 21.03.2023 passed by the Respondent no.5.”
