2 11-11-2024 The present writ petition has been filed
seeking the following relief:-



“1. That this is an application for issuance of an appropriate writ, orders and/or directions, for commanding the respondents to remove the encroachment made by the encroachers (Respondents No. 7 to 14) over public land / Govt. Road, appertaining to Khata No. 203, Survey No. 293, admeasuring 16 Katha & 3 dhurs land, which is causing obstruction to the petitioner and the villagers of village/ Mauza-Inayatpur, P.S. No. 156, P.S.- Daudpur, Anchal-Manjhi, District-Saran at Chhapra.”
