2. The petitioner apprehends his arrest in a case registered

for the offence punishable u/s 341, 323, 354, 379, 498(A), 34 of

the IPC and $\frac{3}{4}$ of D.P. Act.

3. The matter was sent to the Mediation Centre vide order

4. A the mediation report has been sent by the learned
