"1. The present application is being



filed by the petitioner before this Hon'ble Court for a direction /directions to the concerned respondent/respondents to take appropriate action against the respondent No.- 8 i.e. Sushma Kumari to remove/terminate from the post of Constable who has illegally joined the post of Constable in Bihar Police by taking illegal means and apparently she committed forgery of documents so she has no right to work as Constable in Bihar Police which department is known for discipline and honesty."

2. At the outset, the learned counsel for the petitioner seeks not to press the present writ petition, however, seeks liberty on behalf of the petitioner to avail such other alternative remedies as are otherwise available under the law, for redressal of the aforesaid grievances. Liberty, so sought, is granted.

3. The writ petition stands dismissed.
