2 07-08-2024 1. The present writ petition has been filed seeking the following relief(s):-

“1(i) दण्ड प्रक्रिया संहिता की धारा 133 के अंतर्गत जिला समाहर्ता, बेतिया, पश्चिम चम्पारण के समक्ष समर्पित आवेदन पत्र दिनांक 23.06.2023 (उपाबन्ध-2) का विधिवत निष्पादन करने का आदेश पारित किया जाय, जिसमें प्रार्थना है कि मुख्यमंत्री ग्रा. गली नाली पक्कीकरण निश्चय योजना के अंतर्गत पंचायत-हरदीटेड़ा, वार्ड नं0-09 में निर्मित सरकारी नाली जो किशोरी साह के घर से लेकर विनोद भगत के घर से होते हुए रामचन्द्र राम के घर तक गयी है, उसमें आवेदक एवं इनके जैसे लोगों के घरों का पानी गिराने का आदेश पारित किया जाय।”
