3 19-03-2024 Heard learned counsel for the parties.

2. Petitioners apprehend their arrest in a case registered for the offence under Sections 420, 467, 468, 471 and 34 of the Indian Penal Code.

3. Petitioners are alleged to have attempted to procure appointment to the post of 'Junior Engineer' on the basis of forged and fabricated certificate.

4. It is submitted on behalf of petitioners that petitioners have been falsely implicated in this case. F.I.R. has been instituted in haste without holding any inquiry. It is further submitted that had an explanation been given to petitioners to explain their side of the case, perhaps the present F.I.R. would not have been instituted. It is lastly submitted that petitioners have not been appointment on the post of Junior Engineer. Similarly situated two co-accused namely Rajkumar and Sujeet Roy have already been granted anticipatory bail by this Court, vide order dated 08.08.2023 passed in Cr.Misc. No. 42361/2023 and order dated 16.10.2023 passed in Cr.Misc. No. 60288/2023 respectively. Petitioners claim clean antecedent.

5. Learned A.P.P. for the State has opposed the bail petition.

6. Considering the aforesaid facts and circumstances,



let the above named thirty petitioners, in the event of their arrest/surrender within a period of eight weeks from today, be enlarged on bail on furnishing bail-bonds of **Rs. 10,000/-** (ten thousand) each with two sureties of the like amount each to the satisfaction of learned Judicial Magistrate, Patna / concerned court in connection with Sachivalaya P.S. Case No. 39 of 2023, subject to condition as laid down under Section 438(2) of the Code of Criminal Procedure.
