Though the present writ petition has been filed for quashing the order dated 29.06.2024, passed by the learned Court of Deputy Collector Land Reforms, Hilsa, Nalanda in Land Dispute Redressal Record No.71 of 2023-24, however, at the outset, the learned counsel for the petitioners seeks liberty on behalf of the petitioners to challenge the said order dated



29.06.2024, by filing appeal under Section 14 of the Bihar Land Dispute Resolution Act, 2009, nonetheless, seeks some protection, during the interregnum period. Liberty so sought is granted.
